#### **Overview of POA**

At POA, we capitalize on proven systems, sequencing, pacing, coaching, and standards-aligned approaches to student learning. This sets new standards in virtual performance and long-term impact. POA gives local families who want a virtual option the highest quality of virtual education possible in the PSOE model; with the "highest quality" defined by long-term student academic success that reaches above and beyond all other Indiana virtual options.

POA supports Paramount's mission of inspiring learning through an unparalleled academic approach and transforming communities by changing lives through high engagement, consistent collaboration, and data-driven instruction. POA will offer the highest functioning and highest performing K-8 virtual option for school students and their families in Indiana.



- Why Replication in a Virtual Space?
- Paramount's academic model, systems of engagement, and data driven culture have proven to be effective strategies in closing the achievement gap with students.
- Our current schools serve 1,250 students. Of those, 39% (488) remain by choice in a virtual setting. A noteworthy percentage of these families (perhaps as high as 10-20%) will remain in virtual during the next school year. Other local and statewide school systems will see similar trends.
- POA will replicate the focus on readying each child for success in a virtual setting to meet the needs of a dynamically changing parent enrollment base.





- POA will leverage and replicate Paramount's current Family Allies Community Team (FACT) model.
  - Efforts garner +90% attendance at Parent Teacher Conferences.
  - FACT hosts multiple academic-focused parent nights throughout the year.
  - The team utilizes educational backpacks, community resources, community spaces, and school-based information to bridge gaps in the school-family partnership.
- Leadership attends all community meetings and participates in all community events.
- Health Intervention Program
- Mentoring Program for student engagement
- Access to all campuses for programs and extracurricular activities

#### Core Curriculum and Teaching Model

- Standards-based, data driven instruction will continue to be the driving force throughout the curriculum.
- Academic content will be taught using an integrated design with mandatory daily live lessons and high-quality digital curriculum platforms, mirroring the typical blocks of time which segment content areas in on-campus instruction.
- POA will offer focused tutoring and parent training programs onsite for local students and parents, while hosting live evening events for those outside of the local area.



## Core Curriculum and Teaching Model Cyclical Instructional Cycles

At POA, a cyclical instructional cycle allows teachers and students to focus on 1 learning target at a time. The cycle begins with a 15-minute teacher-led mini-lesson followed by a data-driven gradual release process where the teacher monitors student mastery on guided practice problems. Once the teacher has released the students to independence, they have 30-40 minutes to practice the skill while the teacher provides real time feedback in Google Classroom. The cycle ends with a 10-minute standards-based exit ticket that aligns to the rigor of our state assessment (Depth of Knowledge 2, 3, or 4).

## Core Curriculum and Teaching Model Data Driven Environment

At POA, the virtual academic programming includes assessments through Cambium ClearSight (formerly AIRWays) three times per year. This formative assessment platform aligns to ILEARN, the Indiana state assessment, allowing our virtual students to get authentic practice with rigorous item types that align to the Indiana College and Career Readiness Standards. The data breaks down student performance within all power standards, allowing teachers and school leaders to integrate appropriate data-driven modifications to the instruction between assessment cycles.

## Core Curriculum and Teaching Model Collaborative Planning

At PSOE, annual curriculum maps and weekly lesson plans directly align to the PSOE on-campus academic programing. PSOE virtual teachers meet with on-campus teachers once a week for strategic planning sessions to develop weekly lesson plans and review data from the previous week.

## Core Curriculum and Teaching Model Core Digital Resources

POA uses IXL for E/LA and math independent practice support. Lumos Learning, Edulastic, and Smarter Balanced are used for assessment prep. EdPuzzle, Screencastify, and Nearpod are also utilized for response systems and live teacher-to-student feedback.

## Core Curriculum and Teaching Model Early Literacy Support

Virtual students in grades K-2 receive weekly sight word assessments and fluency checks. In addition to our core curriculum (Amplify Core Knowledge) the PSOE virtual program integrates the Orton Gillingham (OG) reading program, which is a multi-sensory technique to reinforce phonics skills. Each virtual teacher is trained in OG.

## School Finance and Proposed Budget Conservative Budget Measures

- PSOE always budgets for extremely conservative inputs and aggressive outputs.
- Conservative enrollment budget practices allow for annual financial flexibility and annual returns of increasing DCOH.
- Grant Income: CSP 2021; Additional competitive grant funding is not budgeted but is expected.



## School Finance and Proposed Budget Budget Stability and Future Schools

- Budget tracks to strong stability (in reserves) in 2023-2024; after school enrollment settles in.
- Student-to-teacher ratios are limited due to a strong focus on success within a personalized academic setting.
