## Lilly Endowment awards Trine University \$17.2 million grant

Trine University has received a grant of \$17.2 million from Lilly Endowment Inc. through its College and Community Collaboration (CCC) initiative.

The grant will support efforts to help prepare students and adult learners for current and emerging in-demand job opportunities throughout the region.

It will partially fund the development of a design and technical training center, the esports facility that serves both the campus and surrounding area, and a new community park, in addition to many other collaborative efforts to enhance the community.

#### Workforce development and collaboration

Key components focus on workforce and skills development and training, collaboration and innovation, community engagement and outreach, infrastructure development and improvement of aesthetics and connectivity, and collaborative university and community spaces and programming. Projects include:

 The state-of-the-art John and Mary Pellegrino Student Design Center will include cutting-edge resources to prepare students and community members for careers in engineering, manufacturing and technology.

- The Mark and Sarah Music/Ruoff Mortgage Esports Arena has transformed an auditorium classroom into a 5,600-square-foot state-of-the-art esports arena. This community-centric space offers inclusivity and engagement.
- The Sheets Community Park will provide for inclusive recreational spaces that encourage physical activity and social engagement for individuals of all ages and abilities.

The grant also will support collaborative programming as well as the development of

new green spaces, trails and recreation spaces that will better connect the university and the greater Angola community.

In preparing a proposal

for the grant, Trine collaborated with several organizations to bring together expertise, resources and diverse perspectives. These partners include the City of Angola and Angola Main Street, Steuben County Government, the Steuben County Community Foundation, Steuben

County Economic Development Corporation, Steuben County Tourism Bureau, Cameron Memorial Community Hospital, Easterseals ARC of Northeast Indiana and RISE, Steuben County Trails, YMCA of Steuben County, Steuben Art Scene, MSD of Steuben County and Fremont Community Schools.

Trine University is one of 13 Indiana higher education institutions receiving grants through the latest round of implementation grants through CCC, a competitive Lilly Endowment initiative.



Trine University's new Mark and Sarah Music/ Ruoff Mortgage Esports Arena is about much more than competition, according to university President Earl D. Brooks II, Ph.D.

"It's a dynamic environment where technology, creativity and community all come together," he said at the arena's dedication. "This place will be used for everything from competitive gaming to academic research and from community engagement to an experiential learning experience. This facility will serve as a living laboratory for students in areas like video production, event management, computer programming and cybersecurity."

The ceremony on Sept. 28, during Homecoming included Mark and Sarah Music, who were honored for their \$250,000 gift toward the project, as well as other members of the Board of Trustees, representatives from Easterseals, community members and Trine alumni, faculty, staff and students.

#### **Cutting-edge technology**

The new 5,600-square-foot arena, located in Best Hall, is designed to accommodate growth in Trine's esports program and in its community partnerships.

The \$2.1 million project transformed an auditorium classroom into a facility featuring 60

state-of-the-art gaming computers. The cuttingedge technology will cater to a diverse range of gaming preferences and skill levels.

The arena includes a spacious spectator area, dynamic competitive battle stage and fully equipped broadcast booth for live streaming and commentary.

"This marks a really exciting new chapter for us and esports as we formally dedicate this space and really raise the standard for us, and I think for a lot of institutions around us, in terms of what an esports arena looks like," Dr. Brooks said.

The new facility will allow the university to expand its esports partnership with Easterseals as well as local schools with esports programs.

Trine has partnered with Easterseals Northern Indiana as that organization has become a national leader with its esports program.

The national Easterseals organization shared its vision for an accessible, inclusive gaming community, dubbed ES Gaming, at a 2022 conference with affiliate leaders. Easterseals Arc CEO Donna Elbrecht recognized the tremendous potential of the initiative and knew Easterseals RISE in Angola was an ideal location to pilot an esports program before expanding it throughout northern Indiana.

Trine University, which has offered esports since 2017 and included an esports arena when it built the MTI Center, was a natural partner as Easterseals developed its program.

## **University presents awards** at Touchstone

Trine University honored alumni, trustees and supporters during the annual Touchstone and Homecoming Celebration Dinner on Sept. 27. The event was held in the Keith E. Busse/Steel Dynamics Inc. Athletic and Recreation Center. In addition to recognizing those who increased their giving level, the university presented several special awards.

#### **Pillar of Success**

**James Fabiani**, part of three generations of the Fabiani family that have served on the Trine University Board of Trustees, was named Trine University's Pillar of Success.

He joined the Trine University Board of Trustees in 2001 after being asked by Trine President Earl D. Brooks II, Ph.D.

His tenure on the board has included serving as vice chair from 2008-2012, during which the university experienced tremendous enrollment and fundraising growth, and completed and launched several major building projects.





#### **Woman of Distinction**

Trine University honored **Jennifer Danic**, president and CEO of the Steuben County Community Foundation, with its annual Woman of Distinction Award.

Danic has led the Steuben County Community Foundation as president and CEO since 2011, but has been part of the community for much longer.

Her parents met at Tri-State (now Trine) University in the mid-1970s and have lived in Angola since graduating. Their love of Tri-State and Trine rubbed off on Danic, who learned to swim at Hershey Hall and golf at Zollner Golf Course, and took part in tennis camps, gymnastics performances at basketball games and other campus activities.

#### **Distinguished Service Award**



**Travis Wilhelm**, a 1999 engineering administration graduate, received the Distinguished Service Award.

Wilhelm has been on staff with Christian Campus House since 2000 and has served as Lead Campus Minister since 2001. Over his tenure, thousands of students have been part of CCH, more than 200 have been baptized, and CCH has conducted 30 mission trips. He also has performed 29 weddings for Trine alumni and given the invocation at more than 70 university events.

#### **Outstanding Achievement Award**



**John Carmichael**, a 2003 business administration graduate, was the recipient of the Outstanding Achievement Award.

At Root and Branch Real Estate LLC, Carmichael focuses on developing projects that drive investment and integrate pressing community needs. He also is president and co-founder of GT Independence, where he previously served as CEO.

In 2008, at age 30, he became the youngest mayor in the history of Sturgis, Michigan.

#### **Outstanding Young Alumnus Award**



**Benjamin Syroka**, a 2016 bachelor of arts in general studies graduate, was the recipient of this year's Outstanding Young Alumnus Award.

Syroka lives in Toledo, Ohio, and works as an attorney for the United States Federal Courts. He was honored with the 2023 Distinguished Pro Bono Service Award at the annual U.S. District Court, Northern District of Ohio ("NDOH") State of the Court Luncheon and received the 2023 "20 Under 40" Toledo Leadership Recognition Award.

#### **Spirit of Trine Alumni Award**



**Donnie Danklefsen**, a 2003 sport management graduate, was the recipient of the Spirit of Trine Alumni Award.

His accomplishments include a record of 638-201 and leading Trine softball to 13 MIAA championships, 13 MIAA tournament titles, eight regional titles, five super-regional championships, a national third-place finish in 2019, national runner-up in 2022 and the first NCAA team championship in Trine University history in 2023.

#### **Athletic Hall of Fame**

Four alumni were named to the university's Athletic Hall of Fame.



**Brandi Dawson** is a 2019 exercise science graduate. A four-year member of the women's basketball team, Dawson was a four-time All-American, named three times by D3Hoops.com and once by the Women's Basketball Coaches Association, as well as a three-time Michigan Intercollegiate Athletic Association Most Valuable Player and a four-time All-MIAA member, three times on first team.



**Kara Morehead** née **Eck** is a 2018 graduate of Trine University with a degree in elementary education and a minor in special education. She was a four-year member of the women's track and field indoor and outdoor teams. Morehead was the first Thunder student-athlete to earn All-American status five times and is still one of just three to reach the mark.



**Will Dixon** is a 2017 graduate of Trine University with a Bachelor of Science in Chemical Engineering. He was four-year member of the men's basketball team. Dixon was named an All-Region player twice and made three first team All-MIAA appearances.



**Isaac Sturgis** is a 2002 graduate of Tri-State University with a degree in social studies education. He was a four-year member of the football team under head coach Dale Carlson. Sturgis was a three-time All-American, including first-team honors from NAIA Coaches in 2001.

#### **Metal 3D printing at MIT**

Garrett Adams, a mechanical engineering and electrical engineering major, worked in Massachusetts Institute of Technology's (MIT's) Mechanosynthesis Group, which aims to advance manufacturing and its interaction with sustainable growth.

The research Garrett assisted with focused on new spreading techniques for metal additive manufacturing, more commonly known as 3D printing.

The end goal, Garrett said, was to develop methods that require less time and power to produce metal 3D prints, while resulting in a smoother surface.

Garrett's responsibilities included redesigning the spreading machine for a new spreading direction, experimentation,

and troubleshooting the laser printer and spreading rig.

"I enjoyed seeing the thought process behind tackling each problem," he said.

#### Fish testing alternatives

Ellie Warhoftig, a biology and environmental science double major from Plano, Texas, participated in an REU at Clarkson University in Potsdam, New York, researching and creating more cost-effective methods to measure contaminants in fish from the Great Lakes.

During her REU, she worked on developing a cheaper

alternative to the expensive EPA test by using chitosan, a material that comes from the shells of shrimp and other crustaceans. She spent a week on a US EPA research vessel on Lake Erie, learning how larger tests are performed and collecting samples for future research.

The program concluded with Clarkson's Research and Project Showcase event, where more than 70 undergraduate students presented their research.

"I ended up placing third overall, which was a great end to the program!" she exclaimed.



#### Oak Ridge National Laboratory: Developing new materials

Marshall Beebe took his passion for chemical engineering to the Oak Ridge National Laboratory (ORNL), where he worked as an ORISE SULI Intern (Oak Ridge Institute for Science and Education, Science Undergraduate

Laboratory Internship). Marshall's research focused on developing high-performance biocomposites for additive manufacturing, specifically by modifying pine fibers with biobased epoxy to improve mechanical properties and reduce the environmental footprint, compared to petroleum-based epoxies.

During his internship, Marshall was responsible for determining the optimal amounts of biobased epoxy, polymer and biomass needed to create the composite, as well as preparing samples for testing.

His work culminated in the creation of biocomposites with wide-ranging applications, including as construction materials due to their low weight, affordability, printability and strength.

At the project's completion, Marshall presented his work at the ORNL research symposium. He also had the opportunity to co-author a research publication.



#### Designing solutions for water contamination

Senior chemical engineering major Natalie Crowner spent her summer at the University of Notre Dame, focusing on creating microparticles for an improved

method of removing contaminants, such as heavy metals and PFAS, from water. Her research aimed to use the particles to attract and bind to water contaminants, creating a continuous system that addresses the limitations of current technologies.

Her responsibilities included creating microparticles, improving their size and shape, and testing their properties.

"I enjoyed how much independence I was given. I made several discoveries, developed methods and adapted procedures on my own," she said.

Natalie presented her research at a symposium at the University of Notre Dame, plans to present at future conferences, and hopes to turn her results into a journal publication.



#### Unlocking the potential of nanocages for hydrogen production

Jake Doyle's REU at the University of Louisville focused on enhancing the efficiency of hydrogen production through the use of a carbon nanocage to encapsulate nickel

sulfide—a novel material for catalyzing the Hydrogen Evolution Reaction (HER).

Jake's responsibilities included synthesizing the nanocages, embedding them with nickel sulfide and verifying their structures using X-ray diffraction. His work culminated in a poster presentation at a nano summit, and the chemical engineering major is now assisting in writing a research paper for future publication.


The long-term goal of this research is to improve the ability to store energy produced by solar panels and wind in the form of electricity, and turn it into hydrogen, which can then be transported to places where renewable energy production is less feasible.

#### Engineering yeast for a greener future

Chemical engineering major Allison Korpi spent her summer at the University of Wisconsin-Madison, working on genetically engineering

yeast to produce isobutanol, a hydrocarbon that can be used as a biofuel for airplanes.

Throughout her experience, Allison was responsible for constructing a gene variant library of yeast, modifying three different enzyme levels and looking at which



"The final part of my project has never been published. It's neat to think that I could be the first person to investigate a certain topic," noted Allison.



#### **Team Goby**

Biology major Peyton Schuring spent 10 weeks at Central Michigan University (CMU) participating in a Research Experience for Undergraduates (REU) program working on the CMU Biological Station (CMUBS).

Peyton spent her summer on Team Goby, an invasive species research team focused specifically on the invasive round goby, a nonnative fish introduced to the Great Lakes in the 1990s via ballast water of cargo ships.

"My specific research was looking into round goby population sizes and body sizes concerning different baiting amounts and capturing techniques," Peyton explained.

Peyton was responsible for creating her own research questions, hypotheses and methodology, as well as conducting her own fieldwork, analyzing her own data and presenting her findings.

## Trine enrolls nearly 15,000 students

Trine University welcomed nearly 15,000 students across its campuses, education centers and online this fall.

The fall headcount total of 14,516 is about a 14% increase over 12,711 enrolled in the 2023 and is almost triple the total enrollment from fall 2021.

The university continues to expand facilities to support its ongoing growth and ensure students have access to modern, state-of-the-art amenities.

The university opened a 36,000-square-foot expansion to Best Hall of Science in fall 2023 to accommodate increased growth in its Rinker-Ross School of Health Sciences and dedicated the 110,000-square-foot Dr. Earl D. and Melanie N. Brooks College of Health Professions facility in Fort Wayne this fall.

#### Trine is Fort Wayne's Best College for 4th straight year; Tolin named Best Professor

Readers of Fort Wayne Newspapers have voted Trine University the Best College in the Greater Fort Wayne region for the fourth straight year.



In addition, **Megan Tolin, 2010 BSSciEd,** dean of Trine University's Franks School of Education, was recognized as the region's Best Professor.

The honors were announced in the Sept. 28 Journal Gazette as part of the newspaper's annual Readers' Choice awards.



It continued a string of recognitions for the university this fall. The university was included among US News & World Report's 2025
Best Colleges and Princeton Review's Best in the Midwest.



#### Trine students assisting FWPD with cold cases

Area unsolved cases are getting new sets of eyes.

Trine University, in partnership with the Fort Wayne Police Department (FWPD), launched a Cold Case Unit in the fall semester.

"We are proud to pioneer this initiative and endorse the police practitioner relationship with our students," said **Erica Hutton**, **Ph.D.**, director of the Cold Case Unit and

assistant professor of criminal justice at Trine.

"There are so many benefits to this program, and we are grateful to the Fort Wayne Police Department for partnering with us. It gives our students the opportunity to work alongside seasoned law enforcement officials and not only learn but implement criminal investigative techniques. And it gives victims' families,

some of whom have been waiting for decades, the opportunity to find closure and justice."

Chief Scott Caudill is excited about the partnership, stating, "This is a mutually beneficial partnership: the students get to work alongside some of the best, experienced, homicide detectives and we get a Cold Case Unit of highly motivated, intelligent students to comb through cases from an entirely different perspective."

Trine students making up the Cold Case Unit for the 2024-25 school year are: **Taylor Colvin**, a psychology major from Macon, Georgia; **Akilah Guthrie**, a forensic science, biology and chemistry major from Anderson, Indiana; **Gracie Schoof**, a criminal justice major from Corunna, Indiana; **Blake Roose**, a criminal justice major from Milford, Indiana; and **Nathaniel Bradshaw**, a computer science and information technology major from New Paris, Indiana.

The unit will be an ongoing effort with the opportunity for students from any major to apply each year.

Trine University dedicated its largest building project ever, praised by its namesake as "a beacon of learning, innovation and service, and a testament to the power of partnership and philanthropy," on Sept. 27.

The new Dr. Earl D. and Melanie N. Brooks College of Health Professions (BCHP) facility welcomed university trustees, officials from Parkview Health and City of Fort Wayne and local media as well as Trine employees and students to christen the \$42.5 million crown jewel, built to transform the landscape of healthcare education in northeast Indiana.

"Through innovative academic offerings and hands-on training, the Brooks College of Health Professions is positioned to meet the growing need for healthcare professionals locally, regionally and beyond," said Trine University President Earl D. Brooks II, Ph.D.

Developed in close partnership with Parkview Health and located at 12817 Parkview Plaza Drive, Fort Wayne, the BCHP opened for classes in August.

The new facility both accommodates explosive growth in Trine University's health professions programs and provides ample space for future expansion.

The university's Board of Trustees voted in May 2023 to name the facility and the academic department it houses in honor of Dr. Brooks and his wife Melanie, in recognition of their transformational leadership, commitment to excellence and impact.

Dr. Rick L. James, president of the Trine University Board of Trustees, closed by recognizing Dr. and Mrs. Brooks. "Together, they have transformed Trine University into a hub of academic excellence and community engagement," Dr. James said. "It is fitting that their legacy is intertwined with the future of healthcare education in our region."

#### State-of-the-art facility

Offering 110,000 square feet of space, the BCHP offers state-of-the-art classrooms and laboratories and features, in partnership with the Parkview Mirro Center, the innovative Parkview Mirro Advanced Medical Simulation Lab (SimCenter), including mock surgery and Emergency Room suites and exam and patient rooms.

Parkview will use the SimCenter and other facilities in the BCHP for training its staff.

The building also contains ample resources for student support, including a library, gathering area, academic support and counseling services. The facility, which eventually will employ 100 faculty and staff and serve nearly 700 students, is home to Trine's programs in physical therapy, physician assistant studies, occupational therapy and surgical technology. Additional degree programs are planned.

BCHP programs offer opportunities for health sciences students on Trine's Angola campus to continue on to graduate school and health professions careers. Several programs offer 3+3 options, which allow Trine students to count their first year of graduate classes toward their undergraduate degree.

The Brooks College of Health Professions began with the university's Doctor of Physical Therapy (DPT) program, which launched in fall 2014 on the campus of Parkview Randallia Hospital. As Trine added additional academic programs, a larger space was needed.

Trine University purchased an additional 43 acres of land from Parkview Health in September 2023 to continue to grow its health professions programs.









Tom Alspaugh said his father planted the seed for his mechanical engineering education and career.

"My father was a tool-anddie maker worked with, and for, engineers," Tom recalled.

Tom excelled in math, science and drafting and developed an interest in mechanical engineering and production engineering.

His parents looked for a small college where he would have a better chance

of succeeding. Tri-State College, now Trine University, was the ideal fit.

"A neighbor, four years older, Bruce Campble, was an electrical engineering co-op student at Tri-State," he said. "There was no question Tri-State was the school we were looking for, and I was going to be a co-op student."

#### Chalk dust, water balloons

One of Tom's favorite professors at Tri-State was Dr. Neil Johnson, who taught Modern Physics. "(He) would get so excited and involved in his lectures he would pound the chalk on the blackboard with chalk dust fling everywhere," Tom remembered. "He really opened my mind up to the realization that there is so much we do not know."

Tom also was very active in Greek life. He had learned about the fraternities at Tri-State when he visited campus but didn't participate during his first and second quarter so he could focus on his studies.

By the end of the winter quarter, four of the five people Tom hung out with on his dorm floor had joined Alpha Sigma Phi.

"When my winter grades came in and I had pulled my second 3.65 in a row, I asked my parents if I could pledge spring quarter, and they agreed," he said. "Alpha Sigma Phi rushed me hard."

His favorite Alpha Sig memories include a water balloon war between the brothers and non-fraternity students across what was now Thunder Drive and the lawn near Best Hall.

He also spent his last summer quarter with one of his fraternity brothers in a rental house owned by the brother's father on Lake James.

"It had a big flat lawn for volleyball and a dock for our fraternity's extralarge pontoon boat," he said. "I took the lightest, easiest class load ever and was out of class at or before 11:00. It was the best summer of my life."

#### On to California

Tom graduated from Tri-State in 1974 with his mechanical engineering degree.

In March 1974, he verbally accepted a job offer from Westinghouse. However, over spring break, he received a telegram from General Atomic in San Diego, California, offering him an all-expenses-paid trip to interview for an engineering job.

Tom was torn because he had committed to Westinghouse, but Alpha Sig brother John Anderson replied, "TOM, ARE YOU NUTS? You have to go to San Diego. I have been there. It is beautiful with great beaches and great weather."

Tom stayed with General Atomic for almost four years but grew tired of the company's lazy pace and research culture.

In 1978, he joined Great Western Solar, California's largest solar company at the time, as vice president of engineering. However, the company went bankrupt in 1980.

He worked as a solar hot water and energy conservation consultant for 11 years but "did not do all that well." His wife, Colleen, had started working with the county probation department and encouraged Tom to apply for government jobs.

In 1991, he went to work for the City of San Diego's Clean Water Program as a senior mechanical engineer. He said the job fit "to a T" and he stayed there until he retired in 2014.

Among his accomplishments were designing a \$250 million sludge processing plant, completing an EPA-mandated central control and monitoring system for the city's 86 sewer pump stations, leading the construction of a 5-megawatt digester power plant and a 1.2-megawatt hydroelectric plant.

A landfill gas collection system he oversaw saved the city \$6 million per year in electricity costs and won the San Diego Tax Payers' Association's 1998 Golden Watch Dog Award. Tom also won San Diego County's Engineer of the Year Award in 1998.

In 2012 his department was named the California Center for Sustainable Energy's Organization of the Year.

#### **Ecuador and Water for People**

His work for the city also introduced him to two ongoing interests: Ecuador and the Water for People organization.

The introduction to Ecuador came through a Clean Water Program picnic that featured Duchicela, an Andes Mountain musical group.

"(They were) playing music Colleen and I had never heard before and we fell in love with its upbeat, light, airy style played with pan flutes, guitars and a mandolin," Tom said.

He and Colleen found out where the group was playing and continued to catch their performances each month. The group invited the couple to come see them in Ecuador and in 1994, the couple traveled there for their 10th wedding anniversary.

"The hospitality was off the charts," Tom said.

By 2006, Tom and Colleen had visited Ecuador six times. They made many

friends there, and operated a small hobby textile business which brought Ecuadorian woven goods back to the United States to sell at a local festival.

Tom heard about Water For People, which promotes the development of high-quality drinking water and sanitation services, from other engineers at water and wastewater industry conferences. Eventually a San Diego committee for the organization was formed and Tom was asked to join.

The couple remains active with the Water For People San Diego Committee. Tom expects the committee will raise more than \$70,000 for Water for People this year.

He received the organization's Raymond Miller Award for outstanding service from the California/Nevada Section in 2010 and remains the San Diego Committee Chair of their annual Jazz Festival.

In addition, Tom continues to stay involved with Alpha Sigma Phi. He chairs the fraternity's Homecoming Committee and the committee attempting to pay off the mortgage for their new fraternity house.

In 2021, he received the Delta Beta Xi, Alpha Sigma Phi Award, given for sustained alumni service to the fraternity.

### Trine University mourns loss of studentathlete Fred Garland

The Trine University community is mourning the tragic loss of **Fred Garland**, a Trine University student and a member of the national championship men's basketball team.

Fred passed away Dec. 11, 2024, in a car accident.

Fred was a senior from Detroit, Michigan, majoring in sport management.

He played a key role in Trine University's NCAA championship run last season and was averaging 14 points per game as a starter this season.

Fred earned First Team all-conference honors in the Michigan Intercollegiate Athletic Association last season, the second season he had been named to an All-MIAA team. He was the Thunder's second leading scorer at 13.4 points per game, sixth in the MIAA.

Percentagewise, he was the team's leading three-point shooter at 44.4% and was fifth in the conference in total field goal percentage at 52.9%. Fred was the team's leading assist man with 3.2 per game.



## Ralph Trine, who impacted every aspect of Trine University, dies at 82

The Trine University community is grieving the loss of its namesake, alumnus, trustee and generous benefactor, Dr. Ralph Trine, who passed away Aug. 14 following a long illness.

What was then Tri-State University was renamed Trine University in 2008 to honor the many contributions of Ralph, a 1961 mechanical engineering alumnus, and his wife Sheri, and to better define the university's mission and direction.

"Ralph Trine is a man whose name literally defines this institution. He and Sheri have supported every aspect of this university through the years, and graciously lent their name to help distinguish this university and launch the incredible growth we have seen since 2008," said Earl D. Brooks II, Ph.D., Trine University president. "I will miss him greatly both as an unselfish, unassuming, quiet leader of Trine University and many other organizations, and as a close personal friend. His passing leaves a great hole, but his great legacy will live on in the lives of generations of students he has impacted and will continue to impact through Trine University."

"Ralph cared very deeply about Trine University, Steuben County and the northeast Indiana region, and that care was reflected through his and Sheri's generous support of many community organizations in addition to the university," said Dr. Rick L. James, chair of Trine University's Board of Trustees. "His passion and skill as a business and community leader greatly benefited the economy and quality of life of northeast Indiana and beyond. His advancement of Trine and the economic development of northeast Indiana and his charitable contributions have helped to propel the institution and region to new levels of prosperity and economic vitality. He will be greatly missed."

Ralph and Sheri Trine both served on the Trine University Board of Trustees, with Ralph joining the board in 1990 and Sheri in 2010. They were named trustees emeritus in 2020.

### Giving back by reinvesting in education

Ralph once said that "reinvesting in the education of students by giving to the university is an outstanding way to give back to the community," and his generous giving reflected that ideal.

The Trines assisted with property acquisition and funded extensive campus beautification and capital construction projects for the university in Angola and Fort Wayne.

They supported remodeling of Forman Hall to include the Trine Welcome Center, the decoration of the renovated C.W. Sponsel Administration Center, the Rick L. and Vicki L. James University Center and the Trine Guest Cottage.

Their donation of the former Angola Christian Church property gave life to the T. Furth Center for Performing Arts, which was renovated as a premier regional performance hall and education center for Trine students, the community and northeast Indiana.

They co-founded the Trine Scholarship Gala with Dr. Earl and Melanie Brooks, which has raised millions of dollars for student scholarships. They also have generously supported Books and Beyond Scholarships and the annual scholarship golf outings.

They purchased and donated the Thunder Gear Store (now the site of Thunder Ice Arena) and Capri, Mattox and Quest Halls. They also built and gifted the president's residence to the university.

In addition, they provided financial support for the construction of the Dr. Earl D. and Melanie N. Brooks College of Health Professions, the Steel Dynamics Inc. Center for Engineering and Computing, the MTI Center, Thunder Ice Arena, Trine Villas and the Ford Hall renovation, among other projects.

The also supported the marble bench project and Trine Thunder athletics.

## **Business and community leader**

Ralph owned Vestil Manufacturing, a fourthgeneration family-owned and -operated manufacturer of industrial material handling equipment. His relocation of the business from Albion, Michigan, to Angola in 1982 led to its expansion to the international arena and has allowed it to employ many Trine graduates over the years.

He holds numerous patents for products developed at Vestil.

In addition to their loyal support to Trine University, the Trines donated funds and facilities for many community projects.

Their donation of the 190-acre, \$2.3 million Oakhill Conference and Retreat Center to the state of Indiana brought the Trine State Recreation Area to Steuben County, preserving a natural treasure for the enjoyment of future generations.

They purchased the land and helped in the construction, furnishings and completion of the Community Humane Shelter of Steuben County, where both Ralph and Sheri were honorary board members. They also donated the building, renovation and furnishings for the Steuben County Community Foundation and the construction of the building for the Heritage Club of Steuben County.

They helped in the construction and furnishings for the Steuben County Regional Airport and founded the Cameron Memorial Community Hospital Benefit Ball. They also avidly supported the YMCA of Steuben County, the United Way, Junior Achievement and the Steuben County Literacy Coalition.

In addition to his service to the university and the Community Humane Shelter, Ralph served on the board of the Boy Scouts of America.

#### **Many honors**

Ralph Trine earned many honors throughout his lifetime for his community service and philanthropy.

Trine University presented him its Distinguished Service Award in 1997 for his contributions as an alumnus, and an honorary doctorate of engineering in 2002. The university bestowed its highest award, the Pillar of Success, upon him and Sheri in 2006.

Ralph received the Congressional Johnny Appleseed Award, established in 1998 to recognize individuals who have made investments for the benefit of future generations.

He was inducted into the Indiana Academy in 2009 for his lifetime of achievement and contribution to the state of Indiana. He received the Sagamore of the Wabash, the highest civil honor given in Indiana, twice, once from Gov. Mitch Daniels and later along with Sheri from Gov. Mike Pence.

Ralph Trine was born Nov. 21, 1941, and married Sheri on July 3, 1965. In addition to Sheri, he is survived by son Barry and daughter Carri, and many grandchildren and great-grandchildren.

#### Football finishes 6-4 as Abbs breaks wins record

The Trine University football team finished the 2024 season with a 6-4 overall record while going 4-3 in Michigan Intercollegiate Athletic Association (MIAA) play with the conference record, earning the fourth spot in the final standings.

After dropping their season opener to a tough squad from Christopher Newport University, the Thunder went on the road to face the Rose-Hulman Institute of Technology for the fourth edition of a battle of engineers. Trine trailed by 21 points late in the third guarter, but completed the comeback for a 39-33 victory, continuing the tradition of the two teams finishing their games in one-possession style. They finished off the non-conference portion of the schedule with a lopsided victory against Bluffton University, 52-20.

After a pair of losses, the second to the nationally ranked and eventual MIAA champions from Hope College, Head Coach **Troy Abbs** led the team to a historic victory against The University of Olivet. The 35-28 final score gave Coach Abbs the 64th win of his career, making him the winningest coach in program history. The Thunder also won games against Calvin University, Adrian College and Kalamazoo College.

Six members of the team were named All-MIAA selections, with **Daniel Budwah** and **Tristan Burrus** highlighting the group as first-team selections. Evan Kaehr, Dan Le-Hernandez, Cam McCarver and Charles Thompson all made second team.


Yin led the delegation from the team that traveled to St. Louis, Missouri, for the ITA Central Regional, winning his opening match before falling to the third seed.


